Protect U.S. Families Holds Republican Members of Congress Accountable for Rising Energy Costs in Pennsylvania

WASHINGTON, D.C. – Today, Protect U.S. Families (PUSF) launched an ad campaign in Pennsylvania's Congressional Districts 1, 8, and 10 designed to highlight the impact of rising gas prices and hold Republican Representatives Brian Fitzpatrick and Scott Perry accountable for their roles in the increase. Both Representatives voted to throw away a limit on liquefied natural gas (LNG) exports. According to a recent <u>report</u> from Public Citizen, LNG exports have contributed to a 52% increase in natural gas prices for U.S. families since 2016. Meanwhile, the campaign commends Democratic Congressman Matt Cartwright for his efforts to prioritize Pennsylvania families by voting to limit liquefied natural gas exports.

The ads will run across multiple platforms, including digital, radio, and print newspapers, over a two-week period. With a total ad spend of \$110,000, this marks the final investment from PUSF for the 2024 election cycle. To date, PUSF has invested over \$1 million in efforts to advocate for policies that benefit American families.


